- vii) submit the quarterly schedule of expenditure from the date of registration upto the date of completion of the project.
- viii) complete the said project by 15.11.2022.
- ix) be bound by the terms and conditions of the agreement already executed with the allottees after the registration dated 13.09.2018. In case the promoter has sold any plot in the colony earlier registered vide registration No. HRERA-PKL-KNL-44-2018, he will remain bound by the terms and conditions of the agreement. Further, on account of this new registration no right of the earlier allottees will be adversely affected in any manner.
